

THE CAR PARLOR HOLIDAY GIVEAWAY OFFICIAL RULES (“Official Rules”).

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED

1. PROMOTIONAL PERIOD

The promotional period begins at 7:00 am HST on Monday, November 19, 2018, and ends at 10:00 pm HST on Sunday, December 30, 2018 (the “Promotional Period”).

2. HOW TO ENTER

During the Promotional Period, participants may enter through the following methods:

- a) Answer questions at www.thecarparlor.com. One (1) new question will be posted daily from Monday, November 19, 2018, through Sunday, December 30, 2018. Every correct answer will earn one (1) entry (“Question Entry”). Limit one (1) Question Entry per person, per day;
- b) Purchase a 3-month prepaid Super Fresh Unlimited Car Wash Package for \$237.00 (two hundred thirty-seven and 00/100 U.S. dollars) and receive forty (40) entries.
- c) Purchase a 3-month prepaid Clean Unlimited Car Wash Package for \$132.00 (one hundred thirty-two and 00/100 U.S. dollars) and receive twenty (20) entries.

3. ELIGIBILITY

The Car Parlor holiday giveaway is open only to individuals who are legal residents of the United States who are at least 18 years of age and living in the state of Hawaii as of the date of entry. Employee and contractors of The Car Parlor and all its related companies, as well as their immediate family members (defined as a spouse or significant other, mother, father, sister, brother, daughter and/or son, and “step” of each) or anyone residing in their household, are not eligible to participate or win The Car Parlor holiday giveaway.

One (1) Grand Prize package will be awarded to a potential winner after the end of the Promotional Period. The Grand Prize package includes four (4) round-trip airfares from Honolulu, Hawaii to Los Angeles, California; three (3) nights hotel accommodations at an Anaheim-area hotel (one (1) room, occupancy up to four (4) individuals); four (4), three-day park hopper tickets to the Disneyland parks; and transportation from the Los Angeles International Airport to Disneyland (the “Grand Prize”). 6. WINNER NOTIFICATION

Potential winner will be notified by phone, e-mail, and/or registered mail on or before January 7, 2019. Potential prize winner will be required to respond within seventy-two (72) hours or prize will be forfeited and may be awarded to an alternate winner.

Once potential winner is notified and confirmed by The Car Parlor, the potential prize winner must sign, have notarized, and return an Affidavit of Eligibility, Liability Release, and unless prohibited by law, a Publicity Release to be signed and returned within the number of days indicated on the Affidavit. In the event that any required documents are not returned within the time frame indicated or if the winner is unable to accept the Grand prize as stated, the Grand Prize will be forfeited and may be awarded to an alternate winner.
